THE FOUNDATION IS THE ONLY FUNDING SOURCE THAT REACHES ALL TYPES OF CHARITIES ACROSS THE OUTER BANKS, SUPPORTING PROGRAMS IN THE ARTS, EDUCATION, PUBLIC SAFETY, HEALTH AND HUMAN SERVICES, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES. THE FOUNDATION AWARDED MORE THAN \$730,000 IN GRANTS AND SCHOLARSHIPS IN 2018 TO 87 NONPROFITS AND 77 LOCAL STUDENTS.
