THE FOUNDATION IS THE VENTURE CAPITALIST OF THE LOCAL CHARITABLE SECTOR, SUPPORTING THE OUTER BANKS'S MOST EXCITING PROJECTS AND MOST URGENT NEEDS, AND HELPING LOCAL STUDENTS OF ALL AGES ACHIEVE THEIR EDUCATIONAL GOALS. THE FOUNDATION IS THE ONLY FUNDING SOURCE THAT REACHES ALL TYPES OF CHARITIES ACROSS THE OUTER BANKS, SUPPORTING PROGRAMS IN THE ARTS, EDUCATION, PUBLIC SAFETY, HEALTH AND HUMAN SERVICES, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES. THE FOUNDATION AWARDED MORE THAN \$1,430,000 IN GRANTS AND SCHOLARSHIPS IN 2019 TO 106 NONPROFITS AND 63 LOCAL STUDENTS.
