THE FOUNDATION IS THE VENTURE CAPITALIST OF THE LOCAL CHARITABLE SECTOR, SUPPORTING THE OUTER BANKS'S MOST EXCITING PROJECTS AND MOST URGENT NEEDS, AND HELPING LOCAL STUDENTS OF ALL AGES ACHIEVE THEIR EDUCATIONAL GOALS. THE FOUNDATION IS THE ONLY FUNDING SOURCE THAT REACHES ALL TYPES OF CHARITIES ACROSS THE OUTER BANKS, SUPPORTING PROGRAMS IN THE ARTS, EDUCATION, PUBLIC SAFETY, HEALTH AND HUMAN SERVICES, DISASTER RELIEF, COVID RESPONSE, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES. THE FOUNDATION AWARDED MORE THAN \$1,139,000 IN GRANTS AND SCHOLARSHIPS IN 2021 TO 69 NONPROFITS AND 51 LOCAL STUDENTS.
