THEY SUPPORT PROGRAMS IN THE ARTS, EDUCATION, PUBLIC SAFETY, HEALTH AND HUMAN SERVICES, DISASTER RELIEF, HISTORIC PRESERVATION, THE ENVIRONMENT, AND ANIMAL SERVICES.
